Building City-Business Partnerships Climate change is a global challenge. But its impacts are felt, and many of its solutions can be found, locally—where we live and where we work. Cities and businesses are each in their own way demonstrating critical climate leadership. Working together, they can do even more.

That's why C2ES and the U.S. Conference of Mayors, which represents more than 1,400 mayors nationwide, teamed up to create the Alliance for a Sustainable Future.

Launched in 2016, the Alliance helps mayors and business leaders find ways they can together reduce carbon emissions, speed deployment of new technology, and respond to the growing impacts of climate change. We share research and best practices, provide a forum for problem-solving, and foster public-private climate partnerships.

The Alliance has brought city and business leaders together in Indianapolis, Miami, and New York City; surveyed mayors on their clean energy and transportation priorities; and produced case studies highlighting key challenges and opportunities. A steering committee led by Santa Fe Mayor Javier Gonzales includes founding sponsors AECOM, Duke Energy, and JPMorgan Chase & Co., and the mayors of Austin, Des Moines, New York City, Salt Lake City and West Sacramento.

Cities large and small are making buildings more energy-efficient, tracking electricity and water use, and encouraging clean transportation. Companies, meanwhile, are investing in clean energy, reducing emissions throughout the supply chain, and helping customers reduce their carbon footprints.

Working more closely together helps both strengthen their contributions to meeting the climate challenge.

Strengthening Global Action

Decades of concerted efforts are paying off with new international agreements to tackle climate change, and C2ES is working closely with key countries to ensure their success.

In 2016, the landmark Paris Agreement officially entered into force. Its pragmatic approach preserves nations' sovereignty while allowing them to hold one another accountable—precisely the sort of agreement U.S. lawmakers on both sides of the aisle have long advocated.

C2ES's behind-the-scenes work with negotiators helped deliver the Paris Agreement and is now supporting its sound implementation. C2ES also rallied business support for Paris, recruiting major companies for full-page ads in The *New York Times* and *The Wall Street Journal* urging President Trump to stay in the agreement.

Beyond the Paris Agreement, 2016 saw two other major international climate accords.

An amendment to the Montreal Protocol phasing down the use of heat-trapping refrigerants called hydrofluorocarbons, or HFCs, could avoid 0.5 degrees Celsius of global warming. C2ES helped address key issues in the negotiations through its detailed analysis of the role of patents, the availability of substitutes, and other technical challenges.

And, in the first-ever climate agreement addressing an entire sector of the global economy, countries adopted a new market-based strategy to cap emissions from international aviation.

Even as U.S. leadership recedes, international climate cooperation continues to strengthen. But even stronger efforts will be needed in the years ahead to ensure that the promise of Paris is fulfilled.

Catalyzing Business Action

In the nearly 20 years since C2ES began working with companies on climate change, business leadership has grown ever stronger. It is now more critical than ever.

Even in the absence of federal leadership, more and more companies are preparing for climate impacts and are seizing the opportunities of a clean energy economy. Their shareholders, customers, and employees expect it. At C2ES, we highlight these climate leaders, help them learn from one another, and lift their voices on critical climate policy issues.

At public events we organized in New York City, Washington, D.C. and at the United Nations climate talks, top company executives outlined why they are investing in efficiency and clean energy and have no plans to stop. As Berkshire Hathaway Energy Senior Vice President Cathy Woollums said, "It's a win for the environment; it's a win for our customers; and it's a win for us."

At our sixth annual Climate Leadership Conference and Awards in Chicago, hundreds of climate, energy, and sustainability professionals exchanged ideas on policy, innovation, and business solutions. Microsoft, IBM, and Mars were among the Climate Leadership Award winners, joining more than 100 other recipients recognized since 2012 for outstanding climate efforts.

C2ES is continually helping companies do more. We contributed to new guidelines to help companies clearly and consistently disclose how climate risks and opportunities affect their bottom line. And we're advising companies on ways they can use an internal price on carbon to reduce emissions and costs and to steer investment toward clean energy and efficiency.

Promoting Climate Resilience

As climate change has evolved from a looming threat to a present reality, preparing for climate impacts has become an inescapable necessity. At C2ES, we're working with states, cities, and businesses to help them assess—and address their growing climate risks.

At workshops across the state of Maryland and in Chicago, Kansas City, Miami Beach, Phoenix, and Providence, we helped public and private sector leaders understand where to find climate data, how to use it, and how they can partner to build and finance climate resilience.

Providence is one of countless communities finding itself on the front lines of climate change. Already experiencing increased flooding, the city also faces rising sea levels, more heat waves, and more intense storms. C2ES helped state and city officials, local businesses, universities, hospitals, and utilities begin examining the risks and ways to respond. As the mayor put it, "We simply can't afford to kick the can down the road."

Cities and businesses have long collaborated in responding to natural disaster. What's needed now is closer collaboration before the fact. For communities across the country working to better prepare themselves for climate impacts, C2ES provides valuable resources and strategies for engaging businesses large and small in strengthening climate resilience.

The C2ES Business Environmental Leadership Council—including top companies in the power, manufacturing, transportation, technology, oil and gas, finance, and other sectors—is the largest U.S.-based group of companies devoted solely to addressing climate change. Over the past year, we welcomed new members Amazon, Apple, Arizona Public Service Company, and Statoil. C2ES works with these business leaders to understand and pursue the policies and technologies that will help us reach our climate goals.

Council members agree to the following principles:



We accept the scientific consensus that climate change is occurring and that the impacts are already being felt. Delaying action will increase both the risks and the costs.



Businesses can and should incorporate responses to climate change into their core corporate strategies by taking concrete steps in the U.S. and abroad to establish and meet greenhouse gas emission reduction targets, and/or invest in low and zero greenhouse gas products, practices, and technologies.



The United States should significantly reduce its greenhouse gas emissions through economy-wide, mandatory approaches, which may vary by economic sector and include a flexible, market-based program. Complementary policies may also be necessary for sectors such as buildings, electricity generation, forestry, agriculture, and transportation that will help drive innovation and ease the transition to a low-carbon economy.



Climate change is a global challenge that ultimately requires a global solution. An international climate framework must establish fair, effective, and binding commitments for all developed and major developing economies.
